Comisiones de Nominación del Comité Nacional

El cuadro a continuación está preparado de acuerdo con la **Nota a los Comités Nacionales y Grupos de ICC sobre la Propuesta de Árbitros** (<https://iccwbo.org/publication/note-national-committees-groups-icc-proposal-arbitrators>) , que explica el papel de los **Comités Nacionales** (<https://iccwbo.org/about-us/global-network/regional-offices/>) y Grupos de ICC (“Comités y Grupos”) en el proceso de nombramiento de acuerdo con las **Reglas de ICC. Arbitraje** (<https://iccwbo.org/dispute-resolution-services/arbitration/rules-of-arbitration/>) (“Reglas ICC”).

De conformidad con dichas Reglas, cuando el Tribunal debe designar un árbitro, se puede solicitar a los Comités y Grupos que asistan al Tribunal al proponer al candidato más adecuado para el nombramiento. Para garantizar la neutralidad del proceso y evitar cualquier percepción de sesgo, se recomienda encarecidamente a los Comités y Grupos que creen una Comisión de Nombramientos a cargo de proponer árbitros a la Corte.

De acuerdo con la política de la Corte de fomentar la transparencia, los Comités o Grupos deben poner a disposición pública la composición de su Comisión de Nominaciones al publicar la información en su sitio web o al enviar dicha información a la Secretaría, que la publicará en esta sección específica del sitio web de la CPI. Si no se pone a disposición del público dicha información o no se actualiza oportunamente, se evitará que el Comité o Grupo Nacional respectivo sea invitado a proponer árbitros.
